***Additional Information on New York Jobs.**

It is critical, however, to recognize the level of Tesla's employment performance in New York State on March 7, 2020, when the Governor declared a disaster emergency. At that date, the total headcount at Gigafactory New York was 1,834, far exceeding the contractual jobs targets for the entire state. More specifically, this workforce included 474 full-time Tesla employees, 984 full-time Tesla independent contract workers, and 376 jobs through Panasonic's co-located manufacturing operation at Gigafactory New York. Tesla also employed an additional 352 people at 15 other locations throughout New York State.
